CERTIFICATION OF CANDIDATES

The Election Committee held a duly called meeting on May 3, 2021 to address the following UIHS Election Policies: Section 6 – Qualifications and Eligibility of Candidates. In accordance with Section 6.4.1., “The Committee will make final candidate eligibility determinations and will present a certified list of candidates to the Board no later than thirty-five (35) days prior to Election Day.” (May 5, 2021)

The 2021 Election is the initial election to establish the rotation schedule pursuant to *Election Policy Section 8.1.2 Rotation of General Election, which states:*

- a) Candidates elected in Area 1 and Area 5 in the initial election to establish the rotation schedule shall serve a three (3) year term.

Candidates elected in Area 2 and Area 4 in the initial election to establish the rotation schedule shall serve a two (2) year term.

The Candidates elected in Area 3 in the initial election to establish the rotation schedule shall serve a one (1) year term.

- b) Following the initial election to establish the rotation schedule, elections shall proceed as follows:

In the first year following the initial election to establish the rotation schedule, an election shall be held for Indian Community Representative for Area 3 for a three (3) year term

In the second year following the initial election to establish the rotation schedule, an election shall be held for Indian Community Representative for Area 2 and Area 4 for a three (3) year term.

In the third year following the initial election to establish the rotation schedule, an election shall be held for Indian Community Representative for Area 1 and Area 5 for a three (3) year term.

In the fourth year following the initial election to establish the rotation schedule, the election rotation for election of Indian Community Representatives to a three (3) year term shall continue as described in this subsection 8.1.2 b), with an election for the Area 3 representative; and the following year, for representatives to Area 2 and Area 4; and in the year thereafter, for representatives to Area 1 and Area 5; and so on.”
